## IMPORTANT REMINDERS

### Choosing A Judge:

- Judge must be an ARHA Approved Judge.
- Judges must not have judged another ARHA Show within 100 miles within 30 days of the show. A Judge may not officiate two consecutive years at the same show or circuit or judge more than 3 shows in one state in one year.
- Arrangements should be made for the judge such as motel, travel, maps, show bill, and any other arrangements. It is strongly recommended that a contractual agreement with the Judge(s) be signed before submitting judge(s) on this show application.

### Show Fees Required with Results Filing:

- \$10.00 per horse per judge is due with Show Result Report.
- Membership & Registration are to be mailed the Tuesday following the show.
- No Show results will be posted without proper payment of fees along with all required and correct paper work files with ARHA.
- Incomplete and/or incorrect paper work or show results may result in fines and exhibitors loss of ARHA Points.

### Exhibitor and Horse Eligibility

Entry in ARHA Approved Shows is restricted to ARHA members in good standing and horses with ARHA Certificate of Eligibility only. ARHA Memberships and registrations may done at the show with a \$10 rush fee and must be submitted at the time of entry. Please confirm that exhibitor has current membership and horse has a ARHA Certificate Of Eligibility (registration).

If a contestant is found to not be a current member and/or a horse is not registered with ARHA, he or she may be fined in the amount of \$50. Failure to pay the assessed fine will be cause for denial of membership/registration. In addition, a \$50 fine per occurrence will be assessed to any show management which allows a person to show without a current ARHA membership card. We will also remove the exhibitor/horse from the show results immediately.

### Statement of Cooperation

As an ARHA Show manager or sponsor, I recognize that I have been entrusted with the American Ranch Horse Association brand, and that my conduct as a manager and/or sponsor is part of a large commitment that fosters growth in ownership of the horse and membership into the Association.
