## Saddle Log General Rules & Enrollment

### Requirements:

1. Participants must be current ARHA members and must maintain membership for the entire time in which hours are recorded toward a recognition level. Membership forms are available at [www.americanranchhorse.net](http://www.americanranchhorse.net) or by calling (606) 271-2963.
2. Horses must be permanently registered before accumulating hours. Participants do not have to own or lease the horse they use in this program.
3. An enrollment application and a one-time enrollment fee of \$50.00 per horse and rider combination must be submitted prior to recording hours.
4. No substitutions of horse or riders allowed.

### Logging Hours:

1. Time may be recorded for any non-competitive activity in which a member participates by riding (i.e. drill team practice, therapeutic riding, trail riding, or riding in a group, parade, clinic, schooling session, lesson, etc.)
2. A separate official Time Log must be maintained for each horse and rider participant enrolled in the program.
3. All time figured is on a one horse-one rider basis and is on the honor system.
4. Actual time spent riding shall be kept in full and one-half hour increments (i.e. 2.5 hours)
5. Participants are responsible for submitting office Saddle Log time Logs to the Association in order to earn recognition or awards. Participants should keep copies of all official Time Logs sent to ARHA.

### Submitting Time Logs:

You will receive a welcome letter and your first official Time Log sheet when you enroll in the Saddle Log program. Once a horse/rider combination is inactive for two years, the record is deactivated and the enrollment fees and hours are forfeited. For additional Time Logs or to enroll another horse or person, you may download the forms at [www.americanranchhorse.net](http://www.americanranchhorse.net). The horse's name and ARHA Registration # along with the riders name and ARHA Membership # must be on log sheet. Incomplete time log sheets will be returned. Time Log sheets must be mailed together in December as well as post marked by December 31 of each year.

**Inactive records will be kept for a maximum of two years  
After such time, the records will be deactivated and point enrollment fees and hours will be forfeited.**
