Entries received after pre entry deadline will go to the bottom of the draw in the Herd Work portion of the class and are not guaranteed fresh cattle. Both owner and exhibitor must be current 2020 ARHA members. Entries are not valid with out complete fees paid. NO CALL IN ENTRIES. Substitution of a horse will be permitted providing the following documentation is received by 6:00 pm on the day before the first class in which the horse is to be substituted. Substitutions must meet the qualifying requirements: substituted horses must be owned by the same person or family. The following needs to be provided: Vet statement that the original horse is unable to compete due to illness or injury; and the entry form is properly completed with all the required information on the horse you are substituting.

I hereby acknowledge that I meet the criteria for eligibility to compete in the classes entered according to the guidelines set forth in these classes and the ARHA rulebook.

Presentation of a signed entry form shall be deemed acceptance of these rules and other rules pertaining to this show. In the event of failure to sign an entry form, the first entry in a class will be deemed acceptance of said rules. BY SIGNING BELOW, I AGREE to be bound by all applicable American Ranch Horse Association, Inc rules and terms and provisions of this entry blank and competition.

Horses competing may only be ridden by one exhibitor. No ARHA points will be awarded. ATRH will not count towards All Around Awards

Payout on America's Top Ranch Hand Challenge will be based on the number of horses* entered plus \$3,000 Added money to the "overall" winners. See World Show Payback scale.

*Must have 15 horses for added money or payback will start with 2nd place money.

- 1) \$200 will go towards cattle costs
- 2) \$200 will be used for administrative costs.
- 3) \$150 of each entry fee will be added to Overall payback.
- 4) Trophy Buckle and \$500 added money will be pay 3 places
 - 1st-\$250; 2nd \$150; 3rd-\$100 on each class "go".
 - a) WCH Reined Work (class 32)
 - b) Herdwork (class 33)
 - c) WCH Fence Work (class 43)
 - d) Cow Catching (class 44)

5)Event will be judge by five (5) Judges with the high/low scores dropped. The Overall payback (\$150 each entry+ \$3,000 added) will be paid on the composite score of the 3 Judges In all 4 events. The overall winner will be awarded the Elite Custom Saddle.

- 6) Each Pre-Entered contestant will receive an ATRH jacket.
- 7) No Refunds. See above about substituting another horse.
- 8) Payback will be made to the person designated on entry form.
- 9) No Payout will not be mailed without completion of W-9 Form.
